Bob Graham reported that the Police Officers Association contributed \$5,000 for the Miracle League Ball Park, and that for the Mud Run this year, they are converting the obstacles from last year to a more portable style for ease of transport. Revenue last year was \$90K with a net of \$70K, and they are projecting \$100,000 net this year. 1,600 runners are expected this year, with \$1,000 in pre-registrations already collected, before we've even begun advertising. #### **Mayoral Candidate Andy Mack**

Dr. Mack, D.D.S. spoke to us today. He has been married to his wife for 30 years and they have 3 grown children who are currently studying dentistry. Dr.

Mack studied at Stephen F.
Austin University and at the
Baylor College of Dentistry. He
owns East Texas Oral &
Maxillofacial Surgery Associates,
has served on the City Council
from '97 to '05, serves with the
Vision 2015 Task Force, and is a
Legacy Longview board
member.

Andy discussed his platform comprised of 5 things.

- 1. Public Safety he is determined to reduce crime in the city and is endorsed by the Police Association.
- 2. Pro-Business Atmosphere he wants to attract new business and promote existing businesses in Longview by improving the laborious process of obtaining building permits, and investment opportunities.
- 3. Fiscal Responsibility he vows to never spend more money than the city receives. If there is \$100 in tax revenues to spend, he will not spend \$120.
- 4. He desires that young people come back to Longview after getting their education. For this goal, he wants to attract high tech companies that pay high

wages. He wants to educate businesses concerning the business friendly environment of Longview.

5. Close the Gap – Dr. Mack believes that certain sections of the city, such as the south and west sides are declining, as opposed to the north side. He wants to unify the city, not by school districts, but by our common city limit boundaries

He also talked about his passion for the city and for the mayor's job. He stressed that he does have the time to be mayor, and that his successful business will not interfere with the mayoral office.

He fielded several questions concerning water distribution, LEDCO attraction of new business, and the current relationships between LEDCO, the Chamber, and the mayor. He also answered questions about donations he had received, and stated that all expenses generated and monies received were reported openly.

He stated that in Longview, 75% of high school graduates don't go to college, and that he envisions cooperation between city and school governments to invest in a technology center that could teach a trade to young people, enabling them to support their families with higher wage jobs.
